

# Planning Information Sheet Section 40 - Certificate of Local Planning Authority

## What is a Liquor Licence and why must one be obtained?

A Liquor Licence from the Department of Local Government, Sport and Cultural Industries is required to be obtained for the sale of liquor from a premises. Local government certification is required to be submitted with the application.

Prior to submitting an application for a Liquor Licence, the applicant must seek a Section 40 Certificate from the relevant local government.

Section 40 certificates are required for all new liquor licensing applications and applications for any alterations to existing licensed premises, including hotels, taverns, cabarets, liquor stores, special facility licenses, restaurants and club licenses. ### **Section 40 Certificate (Local Planning Approval)**

All Section 40 applications must be made via our online lodgment system.

A Section 40 certificate issued by a local government under the *Liquor Control Act 1988* confirms that the premises or proposed premises complies with the local government's Local Planning Scheme. Local governments are able to condition Section 40 certificates, if the premises can only be made to comply with the planning laws, through the imposition of specified trading restrictions. Usually, any trading restrictions specified by a local government would be imposed by the Liquor Licensing Authority as conditions on any license issued. For example, such restrictions could include noise levels or hours of operation.

## **Submitting a Section 40 Application**

# To obtain a Section 40 Certificate the applicant must submit the following information to the City of Canning: A City of Canning Section 40 Application Form; Department of Local Government, Sport and Cultural Industries Certificate of Local Planning Authority – Section 40 (LLD/15) forms (applicant to complete attached); Site plan – showing street and lot numbers (to scale); Floor plan – identification of area proposed to be used as part of license including alfresco areas; Management plan – describing the nature of the business being undertaken and the trading hours proposed and addresses issues such as security on the site, lighting in and around the site, security of patrons leaving the venue, methods of patron control, assistance in departing the venue (availability of direct telephone link to taxi service or public transport location) and noise control; and
