Conditions of Use

RUNNING SPIKES:

- Only "Christmas Tree" and "Pyramid" are permitted
- Spike length limits:





Track Area – 7mm	Field Events – 9mm	High Jump & Javelin – 12mm
------------------	--------------------	----------------------------

- Needle Spikes and Soccer / Football studs are not permitted on the track surface
- Patrons with incorrect spikes will be denied use of the track
- If incorrect spikes are used, the City may a fee for damage to the track.
- Spikes must not be used to mark the track
- Please Note: <u>School Groups are not permitted to use spikes</u>

BARRIER GATES:

- Competition: The barrier gates must be swung off Lane 1 and Lane 2 and locked into place prior to any competition commencing.
- Training: The gates must remain in place on Lane 1 and Lane 2 during any training.

TRAINING:

- Runners are only permitted to run forwards on the track (no backwards running)
- Areas are to be used for their specific purpose (e.g. javelin training can only occur on Javelin Runways)
- Training is to occur away from the three inside lanes

OTHER CONDITIONS:

- Starting blocks must have spikes of at least 15mm
- Vehicles must not cross track surface
- Sand must be swept from the long jump track before and after use
- No chairs or other equipment are to be placed on the track

PAYMENT:

- Please be advised that full payment is required at least 14 days prior to your event.
- If there is less than 14 days to your booking, payment is required as soon as possible. Keys cannot be handed over until payment has been received.


KEYS:

 Keys should be collected from the <u>CANNINGTON LEISUREPLEX</u> on the corner of Wharf and Sevenoaks Street, Cannington. Keys must be collected prior to your event and returned immediately after your booking or on the next day. Cannington Leisureplex is open 7 days a week. Ern Clark Athletics Centre is an unmanned facility, so it's your responsibility to inspect the premises. Should the athletics centre be below standard or have missing/damaged equipment, please call our Ranger & Community Safety Service to lodge a report. Take photos for submission to prevent any additional fees. If you fail to report any issues at the time of entering and this is discovered by the City, then you, will be held responsible and could be charged a fee to cover costs incurred for extra hire time, security call-outs, repairs and any additional cleaning.

Any activity during your booking that triggers a false fire alarm, which results in emergency services attending, may result in a charge of up to \$250, which may be charged directly or deducted from any bond held. Smoking is strictly prohibited inside the facilities.

The use of smoke machines inside City of Canning facilities is strictly prohibited.

Please ensure the facility is correctly armed and all doors are properly locked when leaving. There is a \$120 penalty if a facility is left unsecured. If you have any concerns or questions, please call our Ranger & Community Safety Services
