How charges are applied

Standard Hire Fee applies to:
 Social gatherings, parties, receptions, cabarets, luncheons, player's teas, concerts, fashion parades, bingo, quiz nights, exhibitions, discos, graduation ceremonies, trophy presentation, holy day celebrations/religious functions which includes a meal, funeral or wakes OR other events deemed appropriate by the City's administration. Classes and courses conducted by commercial operators, individuals or not for profit organisations requiring tuition for which a fee is paid, use for commercial promotion activities (i.e. sales promotion); any activity for which admission or participation is charged, leading to a profit for the hirer and/or their organisation (including not for profit organisations).
Note: Hire fee includes permission to consume alcohol within the premises.

Community Hire Fee applies to:
 A discounted hire rate that ONLY applies to Incorporated Community Groups or Not for Profit organisations that provide proof of being registered or situated within the City of Canning. Uses charged at this rate are organisational meetings, church services, rehearsals, band practice, community classes (which may charge a fee to cover costs i.e. not make a profit), exhibitions – non-commercial displays – non-commercial miscellaneous use and other Events deemed appropriate for the rate by the City's administration.
Note: No alcohol can be consumed during a booking that has been charged at the Community Hire fee.

Standard Surcharge

All payments made by Visa/Master credit card will incur a surcharge of 0.60% and Visa/Master debit card will incur a surcharge of 0.40%. As per RBA guideline, effective 1 September 2017 all merchants are permitted to surcharge an amount not exceeding the cost of acceptance and accordingly the surcharge will be amended to reflect the actual cost to the City or different card types.
