Larger events will require a hot buffet style meal with bar service. Monthly Council Dinners shall be a three (3) course meal with table service as required.</p> <p>Smaller groups events will generally be finger foods, sandwiches, rolls, choice of cheese or fruits. The City intends to lead by example a healthy eating lifestyle and food choices to our employees and visitors. Catering will be delivered to the City of Canning Administration Building or other City of Canning locations as requested.</p>
