








INDOOR SPORT AND RECREATION CENTRES

Indoor sport and recreation centres are facilities designed to cater for individual and group physical activities that take place indoors. These facilities provide a safe, all year round environment for a range of activities, such as team competitions and training, individual sport and recreational pursuits, play and fitness activities, and casual hire.

Indoor sport and recreation centres usually contain indoor sports courts, typically used for structured sports, such as basketball, netball, volleyball, indoor hockey, soccer, badminton, as well as unstructured recreational sports booked casually (e.g. casual basketball). These facilities may also include supporting amenities, such as club and community spaces, gyms, changerooms, toilets, canteens, and spectator areas.




CURRENT DELIVERY



There are 2 community indoor recreation facilities provided in the City of Canning. They are outlined below:

CASE STUDIES





WILLETTON BASKETBALL STADIUM

Willetton Basketball Stadium is located at Burrendah Boulevard, Willetton,

The Centre is a highly utilised regional indoor sports centre which caters for Basketball up to State level competition. The Centre includes:

Eight Basketball courts, including a stadium court. Additionally, the multi-court configuration of the stadium also provides for up to 15 badminton courts, four netball courts, and two volleyball courts.

A range of meeting rooms and a function room available as bookable spaces to the general community.

The Centre provides district level competitions at senior and junior level for both males and females.

The Willetton Basketball Association provides a range of skills and accreditation sessions, including after school skills programs, holiday camps, domestic basketball academy, and coach and officials' development programs.

The Centre is well serviced by public transport, with 3 bus routes providing access to train stations and is adjacent to Southlands Boulevard Shopping Centre.

CANNINGTON LEISUREPLEX (SPORT COURTS)

Cannington Leisureplex- Corner Wharf and Sevenoaks Streets, Cannington.

The Cannington Leisure plex is a multi-functional facility featuring the following:

Indoor 10 lane 25m lap pool

Indoor Leisure pool, Wellness Suite-Spa, sauna, steam room

Outdoor splash pad

Waterslide

Gym

Two sports courts

Function centre

Indoor playground

Crèche

Café

Cannington Leisureplex is well located serviced by public transport being adjacent to both Cannington and Queens Park Railway stations and associated bus connections.



INDUSTRY PROVISION RATES AND BENCHMARKING

Parks and Leisure Australia, Western Australia (PLA WA) have developed a provision standard which assesses number of community facility types against the percentage of population of facilities within a catchment. It also reinforces industry's reticence to provide single sport facilities, which aligns with the City's CIS principles.

As it relates specifically to indoor basketball, benchmark data indicates approximately 86% of the City of Canning population live within the designated catchment for an indoor basketball facility.


Volleyball across the state is considered to have a significant shortfall in the availability of facilities. PLA WA and Volleyball WA have identified the need to increase access to existing indoor space or provide additional indoor court facilities.


Netball provisions rates within the PLA WA quidelines for the central metropolitan areas (which includes the City of Canning) articulates that the current provision of netball courts (both indoor and outdoor) is at adequate provision

The PLA WA Community Infrastructure Guidelines 2020 provide the below provisions for indoor sport and recreation centres.

CURRENT BY CANNING

The current City of Canning provision of indoor sports courts is 10 courts, within two facilities as follows:

A two court facility with associated gym, meeting and function rooms and café.

An eight court facility with associated meeting/function rooms and café. This facility is classified as Regional and those in the local community often find it difficult to access. Willetton Basketball Stadium is also under a tenancy arrangement of a ground lease. Willetton Basketball Association manages and operates the Stadium, with no operational influence by the City.

Under the provision standards, the City's provision is adequate. However, given the private nature of the Willetton Basketball Stadium and its predominant focus on basketball, access provisions indicate a shortfall both now and into the future.

A review of similar facilities surrounding the City of Canning shows six indoor sport facilities within a 10km catchment.

All of the six facilities are classified District level, in terms of industry standards and benchmarking, based on their number of sports courts. A District catchment for sports courts is 5km. These facilities therefore provide opportunities for City of Canning residents.

TRENDS

There are a number of trends regarding indoor sports facilities that need to be considered, including:

Limited availability at peak times due to high demand. Peak hours are 3:30pm - 8:30pm weekdays and weekends all opening hours.

Facilities increasingly being designed to accommodate multiple sports and activities. This allows facilities to be used by a wide range of programs, making them more versatile, less restrictive and more cost effective.

Indoor sports courts increasingly being used as community destinations. Many facilities offer programs and events that are open to the public.

Limited provision for basketball and volleyball indoor facilities across the state, as identified by PLA WA.

SportsEye data suggesting that basketball is ranked sixth in participation for males aged 15+. This is not dissimilar to the trends for females, with netball ranked third and basketball seventh amongst the same age group.

Sports participation data from sporteyes indicates:

- There are approximately 2,000 Basketball WA members who live in the City of Canning, 30% of those having to play outside of the City of Canning to access facilities.
- There are 787 Netball WA members who live in the City of Canning, 73% of those having to play outside the City of Canning to access facilities.
- There are 275 Volleyball WA members who live in the City of Canning, 100% of those having to travel outside the City of Canning to access facilities.

Indoor play for Volleyball and netball is restricted to other operators, such as commercial operators or school facilities due to lack of opportunity at peak times within City facilities. These facilities prioritise other uses restricting access to, and growth of these sports.



THE FUTURE

Participation data shows that availability of indoor courts is not sufficient. The City of Canning will need to consider additional courts.

Based on current memberships and demand predictions, a District level indoor sports facility will need to be added to meet Community need (a focus for this should be for indoor netball and volleyball in the first instance).

PROVISION STANDARDS

PLA WA has very general guidelines for standards of provision for indoor sports centres. However, there are more specific hierarchy levels of provision for specific sports, including netball, basketball and badminton. With consideration of each of these standards, the below proposed hierarchy of provision standard for indoor sports in the City of Canning has been developed.

CONSULTATION FINDINGS

This Type received 12 responses, 11 from within the City with 10 respondents currently using this infrastructure. There are five strategic directions/recommendations proposed and all were supported.

KEY THEMES

Capacity and Access: Consistent feedback from respondents that existing facilities are fully booked during peak hours, and an extensive waiting list for some sports.

Indoor Sports Centres: The Bentley/St. James/Wilson areas were identified as lacking adequate indoor sports facilities, which respondents believe are needed.

KEY FINDINGS

There was very high levels of support by respondents to the strategic directions and recommendations.

Community Engagement: Residents express a strong desire for the City to consider their feedback in planning and upgrading indoor sports facilities to ensure they meet current and future needs.

Feedback related to the location and design growth of indoor facilities can be further explored through the business case development outlined in Recommendation 1. Comments highlighted the importance of strategically placing new facilities and expanding existing ones to meet community needs. These insights will inform the planning and feasibility studies to ensure optimal site selection and design improvements.

STRATEGIC DIRECTION



The current provision of indoor sports facilities does not meet the current needs. This will be further exacerbated by increasing sporting trends and participation, as well as the City's forecast population growth to 2041. The City will need to consider the provision of increased access to indoor recreation facilities.



These new facilities will provide opportunities for a diverse range of indoor sports activities and be designed to adapt to the changing needs and demographics of the community to ensure the community has access to quality indoor sports facilities.



Future developments should be co-located with other recreation and/or community infrastructure. (e.g. aquatic centres, gyms, fitness centres etc.)

RECOMMENDATIONS



Develop a business case to address indoor sport court shortfall within the City of Canning, with a focus on development of a District level indoor sports facility co-located with other community infrastructure. The business case needs to consider the extension of existing facilities versus developing new facilities



Investigate and consult on any planned future provision of indoor recreation facilities within neighbouring Councils.
